A. Treasurer's Report: Brooke Skyrme

 - viewed and discussed the treasurer's report
 - Alicia proposed that we increase line item 214 so that we have more funds to provide incentives to students who join PTSA (suggestion of social-distanced activity in the parking lot) – as per Mrs. Diehl we are not allowed to have in-person events at the school due to current conditions.
 - question about "Living History" funds by Sue Williams (sponsored by Mr. Fontaine)
 - moved \$350 from School Morale Boosters line 207 to 214 to make that total \$500 (student PTSA member activities)
 - Bridget Turner made a motion to approve the budget, Sue Williams seconded, 2020-2021 is approved by a 5/7 vote
 - Budget will be posted on our website moving forward
